2010 Appliance Rebate Program

When you purchase an ENERGY STAR home appliance, dehumidifier or programmable thermostat you can receive rebates, reduce energy consumption and help lower your electric bill.

North Attleborough Electric Department (NAED) is offering our residential customers big savings through the end of the year.* NAED encourages you to purchase ENERGY STAR labeled clothes washers, refrigerators, air conditioners, dishwashers, dehumidifiers and programmable thermostats to become eligible for rebates.

Every time you buy a home appliance, dehumidifier or programmable thermostat you are making a decision that affects the environment. You can reduce energy consumption and save money by purchasing energy efficient models. And now, you can save even more money by taking advantage of the Energy Smart Home Appliance Rebate Program from NAED, your locally-owned utility.

*NAEDs Rebate Program is effective January 1, 2010 through December 31, 2010, or when rebate program funds are expended.

What is ENERGY STAR

ENERGY STAR is the symbol for energy efficiency, as designated by the U.S. Department of Energy (DOE) and the U.S. Environmental Protection Agency (EPA). The ENERGY STAR label helps consumers identify products that are more efficient than comparable models.

The yellow ENERGY STAR EnergyGuide Label can be found on your appliances, computer equipment, photocopiers, home electronics, windows, doors and even on your house. Visit www.energystar.gov for more information on all the ENERGY STAR programs.

What defines and ENERGY STAR Appliance

ENERGY STAR Refrigerator: Requires approximately half as much energy as a 13-year old model, which can reduce your electricity bill each month.

ENERGY STAR Clothes Washer: Uses 50% less energy than other models, saving you money all year long in energy and water costs. These washers use faster spin speeds so clothes require less drying time, saving an additional 25% on the clothes dryer energy used.

ENERGY STAR Room Air Conditioner: Must use at least 10% less energy than conventional models. That saves you money on your electric bill!

ENERGY STAR Dishwasher: Uses 25% less energy than the federal minimum standard for energy consumption and uses much less hot water. It can save you \$100 over its lifetime!

ENERGY STAR Programmable Thermostat: Can save you \$100 a year and keep your home comfortable by automatically adjusting your temperature settings while you are asleep or away.

ENERGY STAR Dehumidifier: A qualified 40-pint dehumidifier can save you roughly \$20 per year; this can add up to \$200 or more over the ten-year life of the unit. This could be enough to cover the original cost of the dehumidifier!

How do I qualify for rebates from NAED?

To qualify for a rebate, you must purchase a new clothes washer, refrigerator, room air conditioner, dishwasher, dehumidifier or programmable thermostat with the yellow ENERGY STAR EnergyGuide Label, and it must be installed within the NAED service area before the end of the year*.

These rebate amounts by appliance are listed below:

ENERGY STAR Dehumidifier	\$25

Program Steps:

1. When shopping for your new appliance, look for the yellow ENERGY STAR EnergyGuide Label. Information is also available at area appliance dealers and on the Web at www.energystar.gov.
2. Contact NAED for a Rebate Application, or go to www.naelectric.com and click on the Energy Smart Home button.
3. Purchase a qualifying ENERGY STAR appliance between January 1, 2010 and December 31, 2010.* Limit: Rebates not to exceed \$150/per customer in calendar year.
4. Complete the Rebate Application, attach the original sales receipt showing the brand name and model of the qualifying appliance and the yellow ENERGY STAR EnergyGuide Label. Mail or bring in to NAED, 275 Landry Avenue, North Attleborough, MA 02760-3501; Attn: ESH-2010.
5. NAED staff will validate the information and a check will be issued to qualified applicants. Please allow 4-6 weeks for processing rebates.
6. NAED reserves the right to inspect the installation premises or otherwise verify installation of the appliance.

* This program is effective from January 1, 2010 through December 31, 2010, or when funds are expended. Limit: Rebates not to exceed \$150 in calendar year.

What's in the EnergyGuide Label?

Information about features, capacity, and size.

Clothes Washer Capacity: Standard

Model(s) Maytag MLE2000A

Manufacturer, model number and appliance type used to determine ENERGY STAR eligibility.

Estimates of the appliance's annual energy use (the lower the number, the more energy efficient the appliance and the less it costs to run.)



The ENERGY STAR symbol appears on the labels of most qualified appliances.

The range of ratings for similar models from "uses least energy" to "uses most energy." This scale shows how a particular model compares to others.

QUALIFYING PURCHASES: Only new electric clothes washers, refrigerators, air conditioners, dishwashers, dehumidifiers and programmable thermostats with the yellow ENERGY STAR EnergyGuide Label are eligible for this program and must meet
